#### THE MALAYSIAN TECHNICAL COOPERATION PROGRAM

(MTCP) was first initiated at the First Commonwealth Heads of Government Regional Meeting (CHOGRM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the 2nd CHOGRM in New Delhi, India, to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCDC).

In line with the spirit of South-South Cooperation, Malaysia through the MTCP shares its development experiences and expertise with other developing countries. The MTCP was first formulated based on the belief that the development of a country depends on the quality of its human resources. The programme forms part of the commitment of the Malaysian Government towards the promotion of technical cooperation among developing countries, strengthening of regional and sub-regional cooperation, as well as nurturing collective self-reliance among developing countries.

The MTCP emphasizes the development of human resources through the provision of training in various areas which are essential for a country's development such as public administration, good governance, health services, education, sustainable development, agriculture, poverty alleviation, investment promotion, ICT and banking. Since its inception in 1980, more than 33,000 participants from 144 recipient countries have benefited from the various programmes offered under the MTCP. ## COURSE OVERVIEW

This specific training program on Mixed Development will give exposure to foreign participants on the concept of mixed development and sample of such development in Malaysia. Mixed-use development is a type of urban development that integrates residential, commercial, cultural, institutional, or entertainment purposes, where those functions are functionally integrated and have the end user's convenience and requirement in mind.

Through the course, the Malaysian government expertise, developers or service providers will share their experiences and best practices in development phase that includes planning and designing, construction and project management and relevant facility management activities. In addition, the experts also will share on the maintenance of mixed development projects including transit-oriented development (TOD).

The participants will have the opportunity to visit and study the establishment of the Administration of Malaysian Government at Putrajaya, Setia Alam, Bandar Sunway and KL Sentral – a sample of transit-oriented development (TOD) located in the Klang Valley

- To share and train senior officials and professionals from relevant foreign ministries / government departments / agencies in the integrated township development concept
- To showcase Malaysia's capacity and capability by way of practice in the mixed development in construction sector

## ADMISSION REQUIREMENTS

- Selected government officials and technical experts from the ministries/governmental agencies involved in the planning, design, coordination and managing infrastructure development projects;
- Possess education at least degree level and have at least 5 years working experience in the field related to the program;
- Must demonstrate a good command of spoken and written English;
- Have not participated in any MTCP, previously;
- Must be certified medically fit and not pregnant

Submitted application forms must be accompanied by the applicant's:

- Copy of Passport
- Passport sized coloured photo (3.5cm x 5cm)
- Medical Report

The application must be completed & endorsed by the Ministry of Foreign Affairs/Focal Points responsible for the MTCP program in the applicant's country, then submitted through the applicant's government to the Ministry of Foreign Affairs Malaysia, via a Note Verbale from the applicant's Ministry of Foreign Affairs.

### COURSE FEE AND REGISTRATION

All course fees will be borne by the Malaysian Government under the MTCP

### DAILY ALLOWANCE

Participants will be provided with a daily allowance of RM85.00 that is sufficient to cover daily meals and laundry. However, if meals are provided by the organizer, some portion of the allowance shall be deducted. The amount received varies depending on the training institute

### MEDICAL & DENTAL TREATMENT

Medical treatments are provided at government hospitals/clinics only and the expenses will be borne by the Government of Malaysia under the MTCP. In case of an emergency, participants are eligible to be admitted to government hospitals/clinics. Dental treatments are restricted to extraction and filling only

## VISA-WITH-REFERENCE (VDR)& VACCINATION

Visa and Vaccination, it is mandatory for all the MTCP participants to follow the Visa With Reference (VDR) application procedure. Once the approval is obtained, the training institution should send a copy of VDR approval letter to the participants. Subsequently, with the copy of the approval, the participants may get the VDR from the nearest Embassy of Malaysia. Wherever applicable, participants are advised to arrange for vaccination on their own prior to travel to Malaysia

Expenditures on all visa-related fees, airport tax/airport user's charge, transit insurance, excess luggage, travel tax, transit fees, domestic passenger terminal fees, phone charges, private purchases, etc borne by the participants

### VACCINATION FOR YELLOW FEVER

Participants from some countries are required to take a mandatory vaccination for yellow fever at least 10 days prior to their departure to Malaysia. Yellow Fever certificate is required to be produced upon landing in Malaysia for countries as listed at the link below: <http://www.imi.gov.my/index.php/en/main-services/visa/visa-requirement-by-country.html>

### AIRFARES

The Government of Malaysia shall provide excursion economy air ticket to all MTCP participants from the capital city of the MTCP recipient country to Kuala Lumpur and return air ticket from Kuala Lumpur to the capital city of the MTCP recipient country

### ACCOMMODATION & MEALS

Participants will be accommodated either in the hostel located in the vicinity of the Training Institutions or at the nearby hotels (twin sharing room). Participants are strictly not allowed to bring any family members during the course. Food will be provided for the duration of the course

### MANNERS

Participants shall conduct themselves at all times in a manner compatible with their responsibilities as MTCP participants and abide by the laws, rules and regulations as may be stipulated by the host government in respect of this training course.

### DRESS CODE

During lectures, male participants are required to dress in long-sleeved shirts with ties, long pants and lounge suits and female participants should be appropriately dressed in office attire. For formal occasions – lounge suit or national costume are required.
